January 3 - The beginning of a new year is a good time to re-commit our gifts and energies to obtaining the protection of new life that is under all-out siege in the womb. Let us pray for a new year in the future when we may celebrate legal protection for the unborn.

January 10 - Roe v. Wade is the Supreme Court decision that gave birth to legalized abortion. It is time to take a new look at that historic ruling:

Roe is a radical decision and a legally indefensible one. But what really makes Roe unbearably wrong is its consequences. The result of Roe and Doe has been the legally authorized killing of nearly sixty million Americans since 1973. Roe v. Wade authorized unrestricted private violence against human life on an almost unimaginable scale, and did so, falsely, in the name of the Constitution." January 17 - Faced with the overwhelming impact of Roe v. Wade, many of us—maybe even most—flee from the facts. We deny that the living human embryo is 'truly' or 'fully' human life; ...or we proclaim uncertainty about the facts of human biology; or we proclaim moral agnosticism about the propriety of 'imposing our views on others'; or we throw up our hands and give up because moral opposition to an entrenched, pervasive social practice is not worth the effort, discomfort, and social costs. The one position not on the table—the one possibility too hard to look at—is that abortion is a grave moral wrong on a par with the greatest human moral atrocities of all time and that we passively, almost willingly, accept it as such." January 24 - "After nearly four decades, Roe's human death toll stands at nearly sixty million human lives, a total exceeding the Nazi Holocaust, Stalin's purges, Pol Pot's killing fields, and the Rwandan genocide, combined. Over the past forty years, one-sixth of the American population has been killed by abortion. One in four African-Americans is killed before birth. Abortion is the leading cause of (unnatural) death in America. (Michael Stokes, Law Professor)

January 31- "The right created by the Supreme Court in Roe is a constitutional right of some human beings to kill other human beings. I do not mean for my description to be provocative, but simply direct—blunt about facts. One need not presume that the human fetus has a right not to be killed in order to recognize that, as a descriptive matter, Roe creates a right for one class of human beings to kill other human beings." (Law professor Michael S. Paulsen in *NRL News* 1/16/14)

February 7 – "Whoever receives one such child in my name receives me... See that you do not despise one of these little ones; for I tell you that in heaven their angels always behold the face of my heavenly Father." (Matthew 18:5,10) If Jesus forbids the despising of little ones, it is not hard to imagine what he thinks of killing them.

February 14 - On the topic of men and abortion, syndicated columnist Ruben Navarrette writes, "As I've only realized lately, to be a man, and to declare yourself pro-choice, is to proclaim your neutrality. And, as I've only recently been willing to admit, even to myself, that's another name for "wimping out."

NRL News editor Dave Andrusko comments, "Like too many men, Navarrette accepts that he has no right to speak. Some men do this because they are browbeaten, but many others fall back on this excuse because it gives them freedom to stand on the sidelines and accept no responsibility for what happens to over One Million unborn children each and every year." February 21 – On Planned Parenthood, "Why should the government fund an organization that is so corrupt as to be selling the brains, livers, eyes, legs and other body parts of the babies it kills--not to mention being corrupt enough to kill them in the first place?" (Fr. Frank Pavone, quoted in column in *Catholic San Francisco* by Valerie Schmaltz)

February 28 - "The tragedy exposed here (by the Planned Parenthood videos) is another sign that the safe, legal, and rare approach to abortion was never a tenable position. The dehumanization of unborn children leads to the dehumanization of those who perform abortions, leading from killing living human beings to treating them explicitly as commodities." March 6 - Gianna Jessen, who miraculously survived a saline abortion, is a powerful, living testimony to the awful realities of the abortion industry and the hypocrisy of the abortion rights movement. "If abortion is about women's rights, then what were mine?" Jessen asked. March 27 – As we celebrate the new life Easter brings, there is a growing trend to send people off to eternal life before they are ready. California Governor Jerry Brown said, "In the end, I was left to reflect on what I would want in the face of my own death." What he should have been reflecting on instead were the poor, the disabled, the marginalized, and the elderly who are now exposed to grave and lethal new risks of

fraud, abuse, mistake, and coercion." (Professor O. Carter Snead in *NRL News Online* 10/6/15)
