#### **Margaret Sanger and Planned Parenthood on Minorities**

• Margaret Sanger, *Pivot of Civilization*, New York: Brentano's Publishers, 1922, p. 187. – Sanger claims "All our problems are the result of overbreeding among the working class" and says "...we are paying for and even submitting to the dictates of an ever increasing, unceasingly spawning class of human beings who never should have been born at all...." Their reckless breeding, Sanger said, produced the "dead weight of human waste," which included those who were handicapped, poor, blind, deaf, mute, epileptic, "feeble-minded," mentally ill, diseased, prisoners, prostitutes, or alcoholics.

- In announcing the removal of Sanger's name from one of the flagship clinics of Planned Parenthood's Greater New York affiliate, a spokesperson for the group told the *Washington Post* that

"The removal of Margaret Sanger's name from our building is both a necessary and overdue step to reckon with our legacy and acknowledge Planned Parenthood's contributions to historical reproductive harm within communities of color," Karen Seltzer, chair of the board at Planned Parenthood of Greater New York, said in a statement.
