# Georgia Senate runoff races have national implications!

While we wait for final vote counts in the race for President and in several House races too close to call, it's clear that the Senate will be a crucial firewall for the pro-life movement to block the pro-abortion agenda that would be pushed by Speaker Nancy Pelosi and House Democrats and promoted by Joe Biden and Kamala Harris, if this pro-abortion duo wins the election.

As it stands, Republicans will hold 50 seats to the Democrats' 48. These numbers underscore the critical importance of the two Georgia Senate runoff elections.

Under Georgia law, if a single candidate does not secure 50%

plus one vote, the contest goes to a runoff with just the top two finishers, regardless of party, Loeffler are fighting to hold their seats in the runoff to be held on January 5, 2021. They



competing. This affected both Georgia Senate races.

Pro-life Republican senators David Perdue and Kelly face pro-abortion challengers in Democrats Jon Ossoff and Raphael Warnock, respectively. While Perdue and Loeffler hold 100% pro-life voting records, Ossoff and Warnock support a policy of abortion on demand, which would allow abortion for any reason. Both Democrats support taxpayer funding of abortion and are backed by Planned Parenthood, the nation's largest abortion provider.

These Senate races have national implications.

They will determine whether pro-life Senator Mitch McConnell remains Senate Majority Leader and in a

## Pro-life Women Triumphed in Congress in 2020!

Even with votes still outstanding in several states, one thing is clear: Pro-life women triumphed in 2020! Just weeks after the Senate confirmed Amy Coney Barrett to the Supreme Court, at least 17 new pro-life women are headed to the U.S. House and one new pro-life woman will join the U.S. Senate.

Outlets have called races for Ashley Hinson in Iowa, Beth Van Duyne in Texas, Diana Harshbarger in Tennessee, Kat Cammack in Florida, Lauren Boebert in Colorado, Lisa McClain in Michigan, Maria Elvira Salazar in Florida, Marjorie Taylor Greene in Georgia, Mary Miller in Illinois, Michelle Fischbach in Minnesota, Michelle Steel in California, Nancy Mace in South Carolina, Stephanie Bice in Oklahoma, Victoria Spartz

in Indiana, Young Kim in California, and Yvette Herrell in New Mexico.

As of publication, we are still waiting on final results in several races featuring pro-life women, including Claudia Tenney in New York, Mariannette Miller-Meeks in Iowa, and Nicole Malliotakis in New York.

There were also several prolife women who came close to victory in races no one expected to be as competitive as they were. The prime example of this was Esther Joy King in Illinois's 17th District where she came within just a few points of ousting proabortion DCCC Chairwoman Cheri Bustos. Additionally, Lisa Scheller in Pennsylvania's 7th District, Tiffany Shedd in Arizona's 1st District, and Genevieve

Collins in Texas's 32<sup>nd</sup> District ran strong campaigns against pro-abortion incumbents.

Pro-life female incumbents were also heavily under fire from the abortion industry in 2020 and fended off challenges, including Ann Wagner in Missouri, Elise Stefanik in New York, and Jaime Herrera-Beutler in Washington.

Joining several pro-life women in the U.S. Senate be Cynthia Lummis from Wyoming. Prior to her successful Senate run, Lummis served in the House and had an outstanding pro-life voting record. Senator Joni Ernst in Iowa and Senator Cindy Hyde-Smith in Mississippi both defeated pro-abortion Democrat challengers in their races. Senator Kelly Loeffler in Georgia will advance to a runoff election on January 5, 2021. She

faces Raphael Warnock, who supports a policy of abortion on demand and taxpayer funding of abortion. Loeffler's race is one of two Georgia Senate runoff elections, which will determine which party controls the U.S. Senate.

While we await the final results of the presidential race, we can be heartened by these pro-life gains in Congress. With races still to be called, some are predicting Nancy Pelosi will have the smallest House majority in years. These wins fly in the face of most of the pundits and pollsters who anticipated large scale GOP losses at every level. Here at National Right to Life, we are incredibly grateful for your support and your commitment to voting pro-life in 2020. None of this would have been possible without YOU!

# NRLC praises Senate Majority Leader McConnell's leadership in protecting the most vulnerable members of the human family

At the time of this writing, the 2020 elections have thus far produced a U.S. Senate composed of 48 Democrats and 50 Republicans. There are currently two run-off races scheduled in Georgia for January 5th.

While the Republicans were widely predicted to lose their Senate majority this past election, the election of either Georgia candidate would maintain the Senate under the leadership of pro-life Sen. Mitch McConnell (R-KY). Sen. McConnell easily beat his pro-abortion opponent, and this past week, was unanimously elected to his eighth term as GOP leader.

McConnell, who first became Republican Senate leader in 2007, has held the position longer than any other senator. He has demonstrated an extraordinary commitment to unborn children. unwavering leadership, particularly lifetime on nominations to the courts, has cemented his place in history.

Unborn children and those in the pro-life community owe an immeasurable debt of gratitude to Leader McConnell for prioritizing the pro-life issue. His role in ensuring the conformational of solid, conservative judges and justices has been instrumental. He has stood rock solid when pro-abortion Democrats attacked immensely talented jurists.

For example, in early 2017, President Trump nominated Judge Neil Gorsuch to the U.S. Supreme Court seat left vacant by the 2016 death of Justice Antonin Scalia. Following the 2016 elections, Republicans controlled the U.S. Senate by a slim 52-48 margin. Sen. McConnell had made the election a referendum on what sort of justices ought to be on the Supreme Court

option" -- that is, he forced a Senate vote on whether to create a new precedent, under which only a simple majority would be required to end debate on a Supreme Court nominee. He led Republicans in extending the same operating

which proved to be critical to retaining the Senate majority. Having a pro-life Senate turned out to be critical in the years that followed.

When the nomination of Judge Neil Gorsuch came to the Senate floor in the spring of 2017, Senate Democrats launched an partisan filibuster to prevent an up or-down vote on his confirmation.

Under the Senate's operating rules at the time, 60 votes were required to end such a filibuster, and an initial cloture attempt failed, with only four Democrats supporting cloture (an end to the filibuster). Prolife Leader McConnell then triggered the so-called "nuclear

rule already established by Democrats in 2013, when they were in the majority, for all other presidential nominations, judicial or otherwise.

Over the next years, Leader McConnell ushered in the confirmations of Justice Brett Kavanaugh, and most recently Justice Amy Coney Barrett. According to an interview with the New York Times Sen. McConnell said, "I certainly didn't expect to have three Supreme Court justices. At the risk of tooting my own horn, look at the majority leaders since L.B.J. and find another one who was able to do something as consequential as this."

In addition, Senator McConnell has also fought tirelessly to confirm hundreds of federal judges to the bench. These are the judges that will often be tasked with reviewing the many strong pro-life laws that are passed in the states.

Leader McConnell has also made the life issue a high priority, scheduling votes on important pro-life pieces of legislation. Sen. McConnell co-sponsored and voted for the Pain-Capable Unborn Child Protection Act. This legislation would protect unborn children at 20 weeks, a point by which the unborn child is capable of experiencing great pain when being killed by dismemberment or other late abortion methods.

Senator McConnell coand sponsored voted for Born-Alive Abortion Survivors Protection Act. This Act would require that a baby born alive during an abortion be afforded the same degree of care that would apply to any other child delivered at the same gestational age.

Senator McConnell voted numerous times against using tax dollars to pay for abortion, and he opposes taxpayer funding of abortion providers.

Those in the pro-life community can look forward to continuing important work with Leader McConnell to protect the most vulnerable members of the human family. We congratulate him on his reelection, and will work to help elect two more pro-life senators from Georgia to secure another majority.

# National Right to Life will be heavily involved in two Senate run-off elections in Georgia

Control of the United States Senate will be decided January 5<sup>th</sup> by two run-off elections in Georgia.

After the November 3<sup>rd</sup> elections, there are 50 Republican senators and 48 Democrat senators.

If Joe Biden becomes President, Democrats would have to win both runoffs in the Peach State. With a 50-50 tie, a Vice President Pamela Harris would cast the tie breaking vote as President of the Senate.

National Right to Life's political action committees will be heavily involved in keeping

the Senate under the leadership of pro-life Majority Leader Mitch McConnell (R-Ky.)

A runoff is called for under

Georgia law if no candidate reaches 50%. Pro-life incumbent David Perdue (R), first elected in 2014. received

no candidate 49.7% of the vote. Sen. Perdue Pro-life will square off against propaboration Democrat Jon Ossoff who garnered 47.9%.

Pro-life Sen. Kelly Loeffler (R) will meet the pro-abortion Democrat, Rev. Dr. Raphael Warnock, in the second runoff election. Sen. Loeffler was appointed in 2019 to succeed pro-life Sen. Johnny Isakson who retired because of health issues.

This second runoff was no surprise. There were 21 candidates competing, making it very difficult for any single candidate to reach 50%.





# National Right to Life prevails over pro-abortion EMILY'S List again

The abortion industry hoped for massive gains in the 2020 elections. Top pro-abortion organizations spent millions upon millions to influence hundreds of races. Pro-abortion fundraising behemoth EMILY's List claims it spent \$112 million in 2020—a record

It appears that EMILY's List flipped just one House seat. They won the open seat in Georgia's 7<sup>th</sup> District.

One of the most noteworthy pro-life victories in the House came in Texas's 21<sup>st</sup> District where National Right to Lifeendorsed Rep. Chip Roy

keep this seat in pro-life hands by re-electing Rep. Roy.

Pro-life candidates backed by National Right to Life also defeated EMILY's List incumbents. Those pro-life candidates are Carlos Gimenez in Florida's 26<sup>th</sup> District, Maria Elvira Salazar in Florida's abortion advocates were keen to defeat pro-life champion Sen. Joni Ernst. Throughout her first term, Sen. Ernst was a passionate defender of unborn babies and their mothers. By contrast, groups such as EMILY's List recruited Theresa Greenfield, who supported a policy of abortion on demand and taxpayer funding of abortion. Iowa voters spoke loud and clear. Sen. Ernst won re-election by six points, or more than 100,000 votes.

Kansas. Democrats nominated Barbara Bollier, one of the most outspoken abortion advocates in the state Senate. She was a vociferous opponent of commonsense pro-life legislation, such as Pain-Capable Unborn Child Protection Act, which protects unborn babies at 20 weeks by which point they are capable of feeling pain. Voters soundly rejected her abortion extremism by voting for pro-life physician and Congressman Roger Marshall. The end result was a 12-point win for Dr. Marshall, a margin of victory of over 158,000

Heading into Election Day 2020, the political pundits, bolstered by their supposedly infallible polling, told us to expect a "blue wave." Proabortion groups, such EMILY's List, had massively outspent pro-life groups like National Right to Life. Yet, pro-life candidates prevailed across the country, even in races which were not expected to be competitive.

Never underestimate the power of the pro-life grassroots!



for the organization. EMILY's List only supports Democratic women who support abortion without limits.

Fortunately, they got very little return on their investment. Despite being vastly outspent, it was National Right to Life whose candidates claimed significant victories in Congress.

#### **HOUSE RESULTS**

In 2020, National Right to Life faced off against EMILY's List candidates in 54 of the most competitive head-to-head House races. We were victorious in at least 37 races out of the 54. (Several races have yet to be called but our pro-life candidates remain in a strong position to pull off a win.)

defeated abortion champion Wendy Davis. Many will recall that Wendy Davis, a former Texas state senator, captured national attention when she waged an hours-long filibuster on the Texas Senate floor in hopes of defeating a major prolife bill.

Following her stunt on the Senate floor and the bill's ultimate passage, Davis left the state Senate and ran for governor, another race she lost overwhelmingly.

Such a radical defender of abortion on demand—even late in pregnancy—in the U.S. House would have be detrimental. Despite massive spending on her behalf by EMILY's List, we were able to

#### SENATE RESULT

In the battle for the Senate, we faced off against EMILY's List in four competitive races. National Right to Life's candidates prevailed in Iowa, Kansas, and Texas while EMILY's List's sole victory was in holding incumbent Senator Tina Smith's seat in Minnesota.

In the Iowa Senate race,

#### Polling shows impact of abortion issue in 2020 election

## 23% of voters cited abortion and voted pro-life 31.9% heard from National Right to Life

WASHINGTON – A postelection poll of voters in the 2020 election found that the issue of abortion once again played a key role in the presidential and congressional elections, and that National Right to Life and its state affiliates were key to getting out the pro-life vote for pro-life candidates.

Nationally, 23% of voters said that the abortion issue affected their vote and voted for candidates who oppose abortion. This compares to just 18% who said abortion affected their vote and voted for candidates who favor abortion, yielding a 5% advantage for pro-life candidates.


In states where National Right to Life's political committees were most actively involved, 27% of voters said that the abortion issue affected their vote and voted for candidates who oppose abortion. This compares to just 16% who said abortion affected their vote and voted for candidates who favor abortion, yielding a 11% advantage for pro-life candidates in those high-activity states.

These poll results show that the pro-life vote was a major factor in crushing the "blue wave" from state legislatures to Congress. Overall, National Right to Life's political committees were actively involved in 123 races, including the presidential race.

In those races, 78 (68%) pro-life candidates prevailed, including pro-life Senate candidates in Alabama, Alaska, Iowa, Kansas, Kentucky, Mississippi, Montana, North Carolina, South Carolina, and Texas. A total of seven House races have yet to be called.

The two Georgia Senate races, in which National Right to Life were actively involved for Sens. David Perdue and Kelly Loeffler, are still outstanding and will be decided in January 5, 2021 runoff elections. Both candidates have been endorsed by National

Reagan won the presidency in 1980," said Carol Tobias, National Right to Life president. "As we witnessed November 3, in election after election, National Right to Life, with its network of 50 state affiliates and more than about candidates from Susan B. Anthony List; 8.2% recalled hearing or receiving information about candidates from Women Speak Out PAC; and 10.3% recalled hearing of seeing information from Americans United for Life.



Right to Life and its political committees plan to be heavily involved in the runoff election.

Despite being vastly outspent by pro-abortion organizations such as Planned Parenthood and EMILY's List, pro-life candidates won last Tuesday by significant margins. There were 58 races in which a candidate supported by National Right to Life was running against a candidate supported by the proabortion PAC EMILY's List. Forty (or 71%) of the National Right Life-supported candidates won. Two races remain outstanding, with the pro-life candidate currently leading in both.

"The abortion issue has played a key role in every major election since Ronald 3,000 local chapters, helped provide the margin of victory for pro-life candidates."

Polling also found that voters heard and saw the right-to-life message in the days leading up to the election. The poll found that 31.9% (or approximately 45 million voters) recalled receiving, hearing, or seeing information or advertising from National Right to Life. National Right to Life's state affiliates were also actively involved in voter outreach for the election. Twenty-one percent recalled receiving information or hearing advertising from a right-to-life group in their state. Voters also recalled other prolife groups that were involved in the election: 7.3% recalled hearing or receiving information

National Right to Life mailed more than 7.4 million brochures detailing the positions of the candidates on issues of importance to the right-to-life movement to identified, prolife, registered voter households in key races. More than 5 million voters were reached via social media. Nearly 2 million calls were made to pro-life households in the days leading up to the election with a reminder to vote for the prolife candidate in their area. In addition, more than 58,000 pro-life radio ads were aired on over 3,000 stations

The poll of 1,000 actual voters was conducted by McLaughlin & Associates, November 2-3, 2020, and has a margin of error of +/-3.1%.

## Pro-abortion Democrats took a pounding in the states

Understandably, the fallout from the November 3rd General Elections has focused on the presidency and Congress. We've reported on both extensively at NRL News Today and are doing even more so in this post-election digital edition of National Right to Life News. (Preview. Republicans hold 50 seats in the Senate ahead of the two special elections in Georgia; have gained a number of seats in the House of Representatives; and at least 17 new pro-life Republican women are headed to the U.S. House and one new pro-life Republican woman will join the U.S. Senate.)

While we've posted the responses from many NRL affiliates whose states fared especially well, more needs to be said about the outstanding results in the statehouses, the political hothouses from which many-to-most congressional candidates come.

Here's an early headline from pro-abortion-to-the-brim New York Times: "Democrats' Wave' 'Blue Crashed in Statehouses Across the Country: Democrats failed to flip chambers in Texas, North Carolina, Iowa, Pennsylvania and Michigan. Republicans flipped New Hampshire's Legislature."

The metaphor of the "blue wave" was supposed to apply to both Congress (pro-abortion Democrats were speculating they'd make double digit gains) and to statehouses as well.

"Coming into Election Day 2020, Democrats had high hopes of making inroads in the nation's state legislatures" is the way Louis Jacobson of *US News* put it.

Instead, as Holly Gatling,

the executive director of South Carolina Citizens for Life told *NRL News Today*, pro-abortion Democrats drowned in a "red tsunami" in her state.

Then there is this most revealing opening paragraph from the *Missoula Current*:

Last week, Montana voters gave the GOP unified control of state government, electing year, states will redraw electoral maps for congressional and state legislative districts. It's something the Constitution mandates every decade based on new census data.

In many states, it's up to politicians in state legislatures to do that. Republicans controlled



a Republican to the governor's office for the first time in 16 years, Republican candidates to all statewide offices, and expanding GOP majorities in the state House and Senate.

Remember, most of the action takes place in the states, in which pro-life Republicans have produced many protective laws. Here's the gloomy outlook (gloomy for the Washington Post):

Democrats failed to pick up any state legislative chambers this November, and they could face the consequences of that for the next decade.

That's because next

the mapmaking process in most states after a stellar 2010 election and were able to draw state and congressional districts that made it harder for Democrats to regain power at all levels. After a stronger-thanexpected performance November, Republicans control map drawing in a majority of chambers next year, too, although to a slightly lesser degree.

As David Abrams, deputy executive director of the Republican State Leadership Committee, told the *New York Times*' Sabrina Tavernise,

"Democrats spent hundreds of millions of dollars to flip state chambers. So far, they don't have a damn thing to show for it."

Then there is this insight from Philip Elliott, writing for TIME magazine:

Final tallies are still coming in, so the full picture of Democrats' drubbing isn't vet But clear. after millions of dollars unprecedented attention — to back in control redistricting, the outcome is clearly disappointing to party that started at disadvantage. terms of raw numbers, Democrats had only 5% fewer seats in state legislatures than Republicans. But those 384 seats were in the right spots that allowed Republicans to control 55 of the 99 state legislative chambers in the country.

#### Our Guarantee: You Can Always Rely on National Right to Life

In the last few weeks—prior to the November 3<sup>rd</sup> General Elections—NRLC's media relations' staff received a number of emails and phone calls challenging the information National Right to Life included on materials we published detailing various candidate's position on abortion.

Most people contacting us had already made up their minds about the candidates they were supporting. They were offended that our mailing pieces listed their candidate as a supporter of abortion on demand. Clearly, our callers wished to believe otherwise.

However, everything National Right to Life staff say and what we release to the public is based on fact. Our information is sourced and vetted extensively. NRL takes our reputation for accuracy seriously.

We do not arbitrarily decide who is pro-life or pro-abortion. We base our conclusions on candidate questionnaires (where the candidate tells us—in her or his own words—what the candidate's position is on abortion).

If we do not receive a candidate questionnaire from the campaign, then our materials rely on interviews the candidate gives to local or national media, statements the candidate has made at rallies or during campaign speeches,

and what his or her campaign site says about the candidate's position.

And, of course, we rely heavily on a candidate's voting

everyone has in any context: to be honest and ethical.

As the flagship of the pro-life movement, we are vilified by our opposition which has many, supporting policies that promote abortion on demand. Some voters cling to these evasions as if they are "proof" that the vague assurances of



records—if they have held office prior to the election.

The materials National Right to Life presents to the public go through several departments and are proofed for accuracy.

Every radio ad, mail piece or candidate comparison sheet goes through a multi-step proofing process.

Every statement by a candidate is proofed against official documents such as news reports, published statements by the campaign or campaign speeches. Every vote made by a candidate is double-checked and every policy position taken is verified.

But this is not surprising. The National Right to Life Committee has always been known for its elaborate attention to detail.

And there are many reasons for this, but a primary one that goes beyond the obligation many allies in the media eager to pounce on any inaccuracies. We do not have the luxury of playing fast and loose with the facts. (Of course, we wouldn't anyway.) NRL must have facts backed with supporting documentation so that our materials are unassailable.

Even after showing that a candidate is pro-abortion, we may face several challenges, one perennial. And that is candidates who change the definition of "pro-life" to fit their goals which do not include the protection of unborn children.

Some candidates take a different tact. They prefer to say that they are "personally opposed to abortion" but will do nothing to change the regime of abortion on demand.

These candidates are not pro-life and prove this by their own actions and statements their pro-abortion candidate will somehow mitigate the damage her concrete actions will cause if she is elected.

Unfortunately, this cycle, like every election cycle, we see some people buy into the words of candidates who hope to persuade voters that their position on abortion isn't *that* bad.

But if a pro-abortion candidate tries to persuade you that his or her position on abortion policy won't increase abortions, they are wrong.

Encourage your friends and neighbors to read, learn, and investigate on their own.

And be assured that anything you see or share that comes from National Right to Life will be fully vetted, verified, and documented.

#### A pro-life Red Wave in South Carolina

Republicans won a sweeping victory in South Carolina voting overwhelmingly for pro-life President Donald Trump and pro-life Senior Senator Lindsey Graham. Both candidates were strongly backed by the National Right to Life Victory Fund and SCCL PAC, the federal political action committee of South Carolina Citizens for Life.

Senator Graham crushed his opponent Jaime Harrison by 11 points (54.98 % to 43.61%) to the embarrassment of most pollsters who chronically showed Sen. Graham running neck-and-neck or even behind militant pro-abortion Harrison. Harrison spent \$100 million attempting to defeat Graham.

Norman (C5), and Tom Rice (C7) all retained their seats by extremely comfortable margins. Democratic Congressman Jim Clyburn retained his proabortion stronghold in the 6th Congressional District.

In more good news,

action committee of South Carolina Citizens for Life, endorsed in nine State Senate and State House of Representatives races and won in seven. The House and Senate remain in solid Republican control along with Republican Governor Henry McMaster who was not up for re-election this year.

The State Senate's 27-19 Republican control before the election is at least 35-15 as of this writing, boding well for passage of pro-life legislation which needs procedural support. Since 2018, Democrats with some Republicans have blocked pro-life legislation with procedural votes.

By flipping three seats held by Democrats and a GOP win in an open seat, the South Carolina Senate is looking much friendlier for passing prolife legislation.

In the South Carolina House of Representatives, Republicans held a 79-45 advantage. With all incumbent Republicans retaining their seats and winning three open seats, the pro-life friendly House appears today to have an 82-42 Republican stronghold.

# Twitter Censorship Spikes: Site Restricts Trump and Campaign 111 Times


Through its rampant censorship, Twitter has done its best to silence President Donald Trump. However, neither former Vice President Joe Biden nor his campaign have received any labels or filters of any kind.

Election Day brought with it a huge spike in Twitter's censorship. The company's arsenal used against Team Trump included labels, filters, blocking URLs and preventing users from commenting on certain tweets. This same treatment was also handed to the Trump campaign Twitter account.

Since Nov. 3, Trump's personal Twitter account was censored 35 times as he tweeted about ballots and election counts. Overall, Twitter has censored Trump since May 31, 2018, a grand total of 111 times. In contrast, Biden and his campaign have received no forms of censorship or suppression.

Nine tweets over the past 24

hours were given labels from Twitter. The latest censored Trump tweet, a Nov. 8 video clip from Fox News' "The Next Revolution with Steve Hilton," was given a label: that's the biggest issue. And now with it being about 50 percent of what came in, we have to be able to deal with the nature of the legitimacy of this and if it can be legitimate."



"This claim about election fraud is disputed." However, in the video, Fox News contributor and Washington Times columnist Tammy Bruce simply said, "There's always some kind of fraud, that's unavoidable. But when you're dealing with the most vulnerable voting dynamic, which are the mail-in ballots,

In a second censored clip, Fox Business host Maria Bartiromo discussed with Sen. Lindsay Graham (R-SC) the concept of "dead people voting." Twitter labeled this video with "This claim about election fraud is disputed." Yet, according to 2012 research done by the Pew Center on the States, 1.8 million deceased people were

registered as voters. This topic has been discussed broadly by both sides in the past 10 years.

The third clip, an interview with Sen. Ted Cruz (R-TX) on Fox News' "Sunday Morning Futures," the senator addressed the claims of voter fraud, saying, "The legal process is how you resolve those questions." Twitter also labeled this video, "This claim about election fraud is disputed."

Noted conservative figures like pundit Dan Bongino, The Daily Wire's Matt Walsh, and Paul Sperry, a media fellow for Stanford University's Hoover Institution, have been retweeted by Trump, only to be either labeled or given a filter over their tweets.

In a previous study, Twitter had been found to have censored both Trump and his campaign 64 times.

## Louisiana Right to Life Ecstatic Over Passage of Love Life Amendment to State Constitution

NEW ORLEANS – Louisiana voters approved Amendment #1, assuring that our current pro-life laws are protected and that state judges cannot "find" a right to abortion or the funding of abortion in the Louisiana Constitution.

Known as the Love Life Amendment, Amendment #1 keeps abortion out of the state Constitution and makes sure all policy making remains in the hands of duly elected state legislators. Judges in 13 other states, including Kansas in 2019, found that various pro-life laws unconstitutionally infringed on individual rights, but thanks to the voters of Louisiana, that will not happen here.

Louisiana Right to Life led the push for the amendment's passage through the Louisiana Pro-Life Amendment Coalition, a team of Louisiana citizens and organizations. State Rep. Katrina Jackson (D-Monroe) and state Sen. Beth Mizell (R-Franklinton) were authors of the amendment resolution, which was overwhelmingly supported by both chambers of the Louisiana Legislature as well as Gov. John Bel Edwards.

Benjamin Clapper, Executive Director of Louisiana Right to Life, along with members of the Louisiana Right to Life team watched anxiously as election returns rolled in once the polls closed. The team was ecstatic over the outcome, which confirmed to the nation that

Louisiana is a strong pro-life state.

"Louisiana has overwhelmingly passed the Love Life Amendment and shown its love for mothers and babies!," Clapper said.

"With the passage of this amendment. citizens have mandated that state judges can never use our Constitution to enshrine abortion or the taxpayer funding of abortion in Louisiana. We the people, through legislators, can pass laws defending without the life intervention of judges.

"We encourage other states to pass their own version of the Love Life Amendment. For too long, activist judges around the nation have usurped the power of state legislatures and declared a right to abortion-on-demand. It's time we changed this in every state across America.

"We look forward to the day Roe v. Wade is overturned and Louisiana can once again protect all our citizens, including those waiting to be born. Moving forward, the pro-life movement will continue to support mothers and babies and work toward a day when every child is protected by law and welcomed with love in our nation."





#### Judge rules Alberta city wronged pro-life group by rejecting life-affirming ads

The Court judgment said the city's decision to ban the ads was unreasonable and openly suspected the city's reasoning.

Justice Gates of the Court of Queen's Bench of Alberta has issued a ruling for Lethbridge Pro-Life (LPL) on LPL's court claim against the City of Lethbridge on the City's rejection of all five of LPL's pro-life ads, including an ad which featured a healthy newborn baby with the caption, "Life Should be the Most Fundamental Human Right."

Another LPL ad featured a picture of a pregnant woman with the caption, "Equality Should Begin in the Womb" while yet another said, "Human Rights Should Not Depend on Who You Are."

The Court judgment said that the City's decision to ban the ads was unreasonable because while the City said it conducted LPL's Charter rights in making its decision, its reasons did not show that. The Court also ruled that it was unreasonable to ban the ads on the basis of the LPL's website. It added that rejecting the ads on the basis of inaccuracy does not accord with the right to freedom of expression because, "the fight to freedom of expression does not support the contention It said, "public upset and alarm are not sufficient to tip the balance away from the protection of freedom of expression, and that "... a strong and healthy democracy



that the expression must be widely accepted, accurate or scientifically verifiable."

The Court also ruled on the issue of whether public complaints provide a legitimate basis for prohibiting expression. requires a willingness on the part of the public to accept that the expression of opinions and ideas may, at time, shock, offend and even disturb them."

The Court also underlined that LPL's Charter right includes the

right to share messages some may deem unpopular:

"Freedom of expression is meant to protect minority opinions from being drowned out by the majority."

The Court also found that the decision demonstrated a reasonable apprehension of bias because, in part, the City only looked at the negative responses to LPL's ads and failed to consider the positive ones.

"This decision is a win for every Canadian who prizes the right to share an opinion free of government taking a biased position on one side while neglecting the duty to protect freedom of expression for all" says Carol Crosson, the constitutional lawyer representing LPL.

"The City should have considered our right to freedom of expression, and while the City contended that it did so, the Court found the opposite," commented LPL.

# Premature baby born weighing 11 ounces heads home from the hospital

A baby girl **born** at just 22 and a half weeks and weighing less than one pound has been released from the hospital after more than three months. Harper Rose Schultz

are just so thankful," her mother Emille Wendzik told reporters while leaving the hospital. Harper's father Patrick Schultz added, "It's nothing short of a miracle."



was born June 29 at Saginaw's Covenant HealthCare and is the smallest baby to have ever been resuscitated at the Covenant HealthCare Regional Neonatal Intensive Care Unit.

"She's such a blessing and we

Schultz explained in a video on the hospital's YouTube channel that he and Wendzik went to the hospital because she was having abdominal pain. They did not expect that baby Harper would be born, but Wendzik

had to undergo an emergency C-section.

Micro-preemies are babies born weighing less than 1,500 grams. Harper weighed 320 grams. She was put on a ventilator and her survival rate was low. Babies born at that size have only a 20% chance of survival.

This is the smallest baby that we've ever resuscitated, and to see her grow from where we started to going home now in reasonably good shape, it's mind-boggling for us," said Dr. Martin Nwankwo, a Pediatrix-affiliated Neonatologist at Covenant HealthCare. "We've never done this before. And, to be honest with you, half the hospitals in the United States would not have attempted this."

Dr. Nwankwo is correct. The group TwentyTwoMatters created a

map of all the U.S. hospitals providing this level of care for micro-preemies. On that map are only **100 hospitals** in the U.S. willing and able to treat babies born that young and small. Most NICUs do not have the equipment needed to help such small babies, but Covenant HealthCare does.

Though Harper is still using supplemental oxygen and requires special feedings, she is doing remarkably well.

"It's been nothing short of extraordinary, honestly, it's been amazing care," Schultz. "Everybody involved and the fact that they can take something that small be lifesustaining is nothing short of a miracle, to be honest with you."





#### Tennessee appeals judge's decision striking down state's 48 hour waiting period

Last month we reported on a decision by Senior United States District Judge Bernard A. Friedman to permanently enioined enforcement Tennessee's 48-hour waiting period, which has been in effect since 2015.

On November 4, state Attorney General Herbert Slatery filed a motion in the U.S. District Court in Nashville asking that the law remain in effect while state appeals the decision. The law requires that a woman wait 48 hours after their initial doctor's appointment to have an abortion. Critics argue this requires two visits to the abortion clinic and is burdensome.

The motion "argues that although the state lost at the federal district court level [Judge Friedman], it is likely to win at the 6th U.S. Circuit Court of Appeals because the waiting period law does not violate the constitutional right to an abortion," the Associated Press reported. "Also, the motion says that keeping the law in place during the appeals process will not harm abortion providers, who have been complying with the law for the entire five years it took to get a ruling in federal court."

Judge Friedman "ruled last month that Tennessee's waiting period law serves no legitimate purpose while placing a substantial burden on women who seek abortions in Tennessee," the AP's Travis Loller reported.

When Judge Friedman handed down his decision on October 14, Brian Harris, president of Tennessee Right to Life, responded, saying,

"Not only is this decision a slap at Tennessee's abortionvulnerable women. an affront to Tennessee's voters who passed a 2014 constitutional amendment in which allowing a short waiting period was a key factor." He added. "Our organization remains committed to seeing a similar statute drafted and enforced during the next legislative session."

# UK Government grilled over potential use of body parts of aborted babies

The UK Government has been grilled over the potential use of tissues or organs from aborted babies.

In response to an organ scandal at Alder Hey children's hospital, in which Professor Dick Van Velzen was found to have unethically and illegally collected over 2,000 body parts from 850 children, the Human Tissue Act 2004 was set-up to govern the treatment of foetal tissue.

Under the legislation, it is illegal to sell, or exchange for 'reward', any material that "consists of or includes human cells" – including tissue from aborted babies.

However, the same law allows a competent authority, such as a hospital or research facility, to lawfully engage in that activity and receive remuneration for "transporting, removing, preparing, preserving or storing controlled material".

This is noted by Royal College of Nursing guidelines

which state: "Fetal Tissue may be required for research... If the woman has not expressed any particular wishes about the fetus, she may agree to specific research being carried out. She would be required to sign a consent form to authorise this and to confirm that she fully understands the planned outcome."

It means women are permitted to donate the remains of their aborted baby for medical research.

Sharing his personal concerns and those of his constituents, DUP MP Jim Shannon asked Health Minister Edward Argar "whether the Human Tissue (Quality and Safety for Human Application) (Amendment) (EU Exit) Regulations 2020 address the concerns about the use of tissues or organs from aborted babies, and if so, how is the issue of consent dealt with?".

He added:

"I am being very honest with you, Mr Deputy Speaker, about where I am coming from, because every cell of that little one is precious and must be used with consent and appropriately, just as is the case with those incredibly brave men and women who chose to donate the organs of their lost loved ones in order to save others."

Conservative MP Edward Argar pledged to reviewing the matter saying:

"if it is helpful to him, particularly in the light of his constituents' concerns, I or a fellow Minister will undertake to write to him with further clarification, so that he has that on record. With that, I commend the regulations to the House."



# Planned Parenthood drops lawsuit against Arizona pro-life laws

It is altogether wonderful news but comes seemingly out of the blue and without warning or explanation.

Under the headline, "Planned Parenthood Drops Abortion Restriction Lawsuit in Arizona," Howard Fischer, who writes for Capitola Media Services, tells us "Planned Parenthood has quietly dropped its lawsuit challenging several abortion restrictions in Arizona, including the requirement for a 24-hour waiting period."

Meaning? "Tuesday's action means the state is free to continue enforcing not only the cooling off period but also other challenged restrictions, including who can perform what abortion-related services and prohibiting doctors from prescribing abortion medications by telemedicine," Fischer writes. Even at the time the lawsuit was filed in 2019. Planned Parenthood of Arizona conceded some of the laws had been previously litigated.

No one would explain to Fischer why they told U.S. District Court Judge Jennifer Zipps "to dismiss the legal challenge." All they did provide, according to Fischer, was "a written statement about

its ongoing concerns about the statutes in question."

As we wrote back in 2019, Planned Parenthood said the laws were "medically unnecessary. According to Dustin Gardiner of the Arizona the three areas at Republic issue are (1) the requirement that only physicians may perform abortions; (2) that after meeting with the abortionist, the abortion-minded woman wait 24 hours before (if she chooses) to have an abortion; and (3) the ban on using telemedicine/ video conferencing as a way distributing chemical abortifacients without the abortionist ever meeting with the woman.

However, pro-lifers speculated that the withdrawal was in response to a "changing legal environment." That would include the replacement of Justice Ruth Bader Ginsburg with Justice Amy Coney Barrett. But it also could reflect cases decided since the Supreme Court's decision in *June Medical Services, L.L.C.* v. Russo. Here's Fischer's summary:

In June the U.S. Supreme Court did rule 5-4 that Louisiana


