## Catholic Colleges Offer Internships with Pro-Abortion Groups

Contrary to the teaching of the Catholic Church, some ten or more Catholic colleges are promoting student internships with groups that are actively pro-abortion, including Planned Parenthood, the nation's largest abortion provider; Feminist Majority Foundation (FMF) which supports late-term abortions; the National Organization for Women (NOW) and NARAL who lobby for abortion "rights." The FMF internship training includes working in "clinic defense," opposing pro-life advocates providing help and information to women outside abortion clinics.

Boston College, Georgetown University, DePaul University, the University of San Francisco, Notre Dame, St. John's University of Minnesota, St. Edward's University in Texas and St. Norbert College in Wisconsin are among those who are offering college credit, and sometimes funding, for such internships.

The Cardinal Newman Society is writing to the presidents of these colleges to protest these internships opposed to the mission of a Catholic college.

#### Anti-Rationing Amendment to Health Care Bill Defeated 12-10 in Senate Committee

WASHINGTON- The Senate Health, Education, Labor and Pensions Committee defeated on a party-line vote an amendment offered by Senator Michael Enzi of Wyoming, the ranking Republican member, to the pending health care restructuring bill that would have prevented the use of "comparative effectiveness" research methodologies as a basis for denial of benefits to patients against their will based on their age, expected length of life, or of the patient's present or predicted disability or quality of life. Senators Enzi, Gregg, Coburn and Burr spoke in favor of the amendment.

In one example in the medical literature, an attempt was made to assess different "quality adjusted life year" scores for each of the following: "no physical disability, limp, walk with crutches, and need a wheelchair." In another, the authors wrote, "[I]t may be judged that one year of life with a moderate disability is equivalent to 0.75 years of life at optimal health."

Senator Barbara Mikulski (D/Md) lead the opposition to the amendment, claiming it was unnecessary. However, while the existing bill language says that comparative effectiveness research such as this "shall not be construed as mandates FOR payment, coverage, or treatment," **nothing in the current bill prevents it being used to DENY treatment.** 

"By rejecting the Enzi amendment, the Senate HELP Committee today cleared the way for that rationing to be based on discrimination against people with disabilities, older people, and anyone considered to have a poor 'quality of life,'" charged Burke Balch, director of the National Right to Life Committee's Powell Center for Medical Ethics.

# Tell Congress to Exclude Abortion from "Health Care Reform"!

Democratic congressional leaders, who are currently in control of both houses of Congress, are working with the Obama White House to fast-track sweeping "health care reform" legislation -- legislation that Barack Obama has already pledged will incorporate expansive pro-abortion provisions. Committees in the Senate and House are already working on bills that would result in mandatory insurance coverage of abortion-on-demand, and federal subsidies for abortion.

Douglas Johnson, NRLC director of federal legislation, noted that the authors of the bills hope to achieve sweeping pro-abortion effects without even mentioning the word "abortion." For example, a bill proposed by Senator Ted Kennedy (D/Mass.) would grant authority to a "Medical Advisory Council," appointed by the Secretary of the Health and Human Services, to specify what services must be included in all health insurance plans. A draft bill released by the House Democratic leadership on June 19 contains a similar provision.

"Pro-life Americans should vigorously oppose any federal 'health care reform' legislation that does not explicitly exclude abortion from the scope of any government-defined or government-mandated package of health care services," Johnson explained. "A bill that delegates authority to some government board to require abortion coverage is simply a covert, two-step method for imposing sweeping pro-abortion mandates on employers and all citizens."

Fr. John Rafael

Fr. Rafael Challenges Pro-Life and Black Communities to Build Bridges of Communication

At the National Right to Life Convention Prayer Breakfast (6/19), Keynote Speaker Fr. John Rafael, SSH, told the pro-life attendees that the pro-life community and the African-American community have much in

common regarding the respect for human life but have not connected with each other sufficiently.

As a Black priest from New Orleans, and chairman of the Josephite Pro-Life Committee, Fr. Rafael has worked for nearly 20 years to raise the consciousness of Blacks regarding the plight of the unborn. He sponsors regional workshops for pro-life education. In his talks, he finds that African-Americans listening to him nod in agreement, but when it comes to voting, even the most pious pro-lifers will vote for a pro-abortion candidate because of social-cultural reasons. Fr. Rafael believes that the black population needs to be convinced that the life issue is so important that they would insist that whoever asks for their vote should be pro-life.

A dramatic focus on this issue arose May 17 when Obama was given an honorary degree at Notre Dame. This was an intense experience for Fr. Rafael who is a Notre Dame graduate. During the election, the African-American boys in the high school in New Orleans where Fr. Rafael teaches were ecstatic that an African-American man could break the racial barrier to become president. Fr. Rafael had been carrying on a pro-life information crusade with abortion statistics, parallels between abortion and slavery, comparison of the number of black deaths from abortion to total black deaths--pointing out the genocide happening when a black population of 13% has 37% of abortions--highlighting Planned Parenthood's concentration of abortion clinics in minority neighborhoods, and relating the history of Margaret Sanger's "Negro Project" to reduce births among blacks.

As we know, these facts did not change "the racial mandate" in the black community bursting with pride in a black leader who could become the U.S. president. But after Obama was elected, Fr. Rafael pointed out that the Obama Abortion Agenda was real and had real victims.

When it was announced that Notre Dame would honor Obama, Fr. Rafael was dismayed at the position this put him in, and the Church as well. If it was okay with Notre Dame to honor a proabortion president, then it must be okay with the Church. He felt he was suddenly transformed into "a quirky priest with a personal agenda."

Fr. Rafael chose to participate in the Rally for Life at Notre Dame on May 17. He shared that the religion writer for the local newspaper, in a front page article, gave a fair and balanced explanation for his participation in the pro-life rally. Yet African-Americans responded angrily, both to the article and to Fr. Rafael. Nevertheless, he felt that, after years of trying to provoke anger at abortion and getting only a yawn, the newspaper article did more to draw attention to the issue than anything else.

When the black priest from New Orleans arrived at the rally, he was welcomed with open arms by the pro-lifers. But Fr. Rafael commented that to his black brothers and sisters he was "an enigma at best and a traitor at worst." So he asked himself why these two communities have not been able to connect with each other better. He pointed out that black culture has been forged of suffering and is a world often alien to white pro-lifers. Two moral concerns seem to stand in contradiction: the racial issue and the life issues. Logically, of course, these two concerns are not in contradiction. Yet social and political history have placed them in opposition. Is it possible to overcome this divide?

Fr. Rafael urged a strong bridge of communication between the pro-life and black communities to educate the average African-American on the importance of protecting the lives of unborn black children. This needs to be done in terms meaningful within the black community, speaking about their fight for justice and relating this to the injustice to black mothers, families and unborn children in the abortion agenda. Larger resources need to be devoted to this educational work, building on those efforts already made. Better public relations also should let the public know of all the good work pro-lifers have done for years helping pregnant women of all races, before and after birth, with generous support. "Being pro-life is...a way of life that places specific burdens and responsibilities on us... But victory belongs to the children of God," Fr. Rafael emphasized.

#### Polls Show Majority of Americans Are Pro-Life Opinion Is Moving in a Pro-Life Direction

Several polls confirm that the opinion of Americans is becoming more pro-life. A pro-life attitude toward abortion is now the majority view.

The Polling Company conducted a survey for National Right to Life Committee in the days after last fall's election and found that 53% of Americans took a position of opposing all or most abortions, and only 41% favored legal abortion in either part or all of pregnancy. Only 6% took the position of President Obama allowing abortion for any reason at any time during pregnancy.

A recent Gallup Poll revealed that more Americans identify themselves as pro-life than at any time in the last 15 years. It found that 51% say they are pro-life and 42% describe themselves as "pro-choice" on abortion. The poll also found that 59% of Americans oppose Obama's decision to overturn the Mexico City Policy and allow our taxes to fund groups that promote or perform abortions in other countries.

The same Gallup Poll revealed that 60% of Americans think abortion should either be illegal in all circumstances or legal in only a few circumstances.

At the National Right to Life Committee Convention in June, Dr. David O'Steen, NRLC's executive director, said that he believes the shift in the pro-life direction is a result of Obama's extreme pro-abortion record, including using taxpayer money to fund overseas organizations that perform and promote abortion and to fund embryonic stem cell research. He pointed out that Obama's record has gotten more play in the press than some may have expected. O'Steen said he thought that "pro-choice" rhetoric is breaking down because people are seeing how those who say they are "pro-choice" are routinely promoting abortion.

Roe v. Wade will eventually be overturned, Dr. O'Steen asserted, because it stands contrary to the laws of God and the moral values of most Americans.
