It's Time to Fish or Cut Bait

Events in 2012 may well determine the future of the pro-life movement for decades to come. During the past thirty-four years I have been part of or witnessed much of the pro-life movement's history. While we have not reached our ultimate goal of banning abortion, the movement has made steady progress in limiting some aspects of abortion and in educating the public on abortion and other anti-life issues. However, during the past three years, the Obama administration has undermined or reversed many pro-life initiatives.

For example, on January 21, 2011 President Obama reaffirmed *Roe v. Wade*, which legalized abortion on demand pledging, "*I am committed to protecting this constitutional right.*" In addition, he blocked attempts to cut off funding for Planned Parenthood, attempted to remove the ban on funding abortions in the District of Columbia, issued an order to fund private organizations that perform and promote abortions overseas, and issued an executive order rescinding a regulation that would have protected health-care providers from being penalized for refusing to provide abortions.

Unfortunately, the administration's most damaging action to date is the hydra-headed monster commonly known as Obama Care. It contains a myriad of anti-life provisions and mandate powers through which the administration can promote abortion, eliminate conscious clause protections, and establish mechanisms of government controlled health care rationing.

Using the mandate powers in Obama Care, President Obama is trying to force religious institutions and individuals of conscience to pay for health insurance plans that cover medical procedures and drugs which act against their religious beliefs and consciences. By simple extension of these existing mandate powers, Health and Human Services could easily include abortion as a required medical procedure to be covered by health care plans.

President Obama has tried to claim that the current objections to Obama Care come only from those who are opposed to contraception. Yet, as the Catholic bishops have repeatedly pointed out, the current debate is not about contraception or any other specific teaching of any religion. It is about the government trying to control how churches and religious believers live out their faith. What Mr. Obama appears incapable of understanding is how deeply committed Americans are to the principles of religious freedom on which the United States was founded. Whether people identify themselves as Catholic, Lutheran, Baptist, Evangelical, Fundamentalist, Mormon or Jewish, they understand that the government does not have the right to

force religious individuals, organizations, or churches to violate their consciences or act in a manner contrary to the teachings of their faith.

Attacks on religious institutions by abortion activists are not new. In the late 1960's and early 70's, Dr. Bernard Nathanson and Larry Lader, who were founding members of the National Abortion Rights Action League (NARAL), targeted the Catholic bishops, After his conversion to a pro-life position, Dr. Bernard Nathanson revealed a key strategy used by NARAL in his book, Aborting America. Lader's strategy for breaking down opposition to the legalization of abortion centered on demonizing the Catholic bishops.

"Historically...every revolution has a villain,..."

"Not just all Catholics....that's too large a group...we have to convince liberal Catholics to join us, a popular front as it were,... [the villains have] got to be the Catholic hierarchy. That's a small enough group to come down on, and anonymous enough so that no names ever have to mentioned but everybody will have a fairly good idea whom we are talking about."

There is no accurate way to evaluate the effect of NARAL's anti-Catholic strategy almost four decades ago, but the statements of current Obama administration officials seem to be taken chapter and verse from the early NARAL play books. The current attacks on religious liberty has similarities in its reliance on casting Catholic principles as anti-woman, anti-progressive religious oppression. The manner and temerity with which Mr. Obama presented his mandate demands did nothing to soothe their impact. By drawing a line in the sand demanding religious institutions violate their beliefs, he has created a chasm too wide to bridge.

Many legal analysts have also pointed out that the current mandates are only the first step. Obama Care is riddled with provisions that will allow the administration to require funding of abortion via insurance coverage, as well as promoting euthanasia through health care rationing. Repealing Obama Care may be the last hope for several decades to prevent our nation from sliding down a slippery slope into government sponsored abortion and massive health care rationing.

Although the major media outlets and culture of death forces are trying to keep the public's focus on the red herring issue of contraception, many pro-life organizations and other groups of concerned citizens have recognized the threat and are coalescing in their opposition to these attacks on religious freedom. Americans have recognized that an attack on the conscience rights of anyone is an attack on all. If the Obama administration is allowed to continue its relentless anti-life campaign, human rights and freedoms in this country may be compromised for decades to come. It is time for people of faith to fish or cut bait - - act or be acted upon.

Religious Liberty Advocate, Archbishop Lori Appointed to Lead Baltimore Archdiocese

Archbishop William Edward Lori, 62, of the Diocese of Bridgeport, CT, has been named by Pope Benedict XVI as the 16th archbishop of Baltimore.

Archbishop Lori serves as the Chairman of the newly formed Ad Hoc Committee for Religious Liberty which was established last September by United State Catholic Conference President Timothy Cardinal Dolan, to fight political threats which

violate Catholic teaching. Archbishop Lori's statements and testimony before Congress have been strong, direct, and eloquent. In testimony delivered to a congressional committee Archbishop Lori's now famous parable of the Kosher Deli and the Pork Mandate has gone viral on social network all across America:

The appointment to the Baltimore Archdiocese comes at a curial time as a result of attacks by the Obama Administration's on individual consciences and religious liberty through mandates issued by the Secretary of Health and Human Services. Archbishops Lori's appointment to Baltimore is viewed by many as a sign of the importance of the religious liberty issue and would seem to indicate appreciation for Archbishops Lori's leadership, talents, and courage.

Prior to being appointed Bishop of Bridgeport Connecticut, Archbishop Lori served as auxiliary bishop for the Archdiocese of Washington. Originally from Louisville, KY, he received a bachelor's degree from St. Pius X Seminary in Kentucky and later earned a master's degree from Mount St. Mary's Seminary in Emmitsburg, Maryland, which is in the diocese of Baltimore. He then continued his studies and received his doctorate in sacred theology from The Catholic University of America in Washington, D.C.

Archbishop Lori was elected the 10th supreme chaplain of the Knights of Columbus a Catholic lay fraternal organizations with which he has had a longtime affiliation. "The Knights of Columbus is an amazing lay organization, predominantly, that already supports family life in very magnificent ways, supports the dignity of human life, and also the vocations of priestly and religious life, as well as a solid healthy patriotism," then Bishop Lori told CNS upon his 2005 appointment.
