# **United Methodist Church Agencies Should Withdraw from RCRC**

The Religious Coalition for Reproductive Choice (RCRC) is dedicated to preserving the right to obtain an abortion. According to RCRC's president and CEO, The Reverend Carlton W. Veazey, "RCRC was founded in 1973 to safeguard the newly won constitutional right to abortion." (www.rcrc.org/about/index.cfm, 12/10/06) Theologically, morally, politically, and legally, RCRC works to maintain abortion rights.

Consider this picture. A facility that provides abortions goes about its business, day after day. RCRC works to help make sure this facility stays open so that abortion services are available to those who would desire them. Theologically, RCRC strives to assure the religious community that abortion rights are ecumenically and interreligiously supported. That is, RCRC provides theological and religious legitimization and cover for abortion rights. ...RCRC instructs that [adult] agency or decision-making authority can and

should override any concern for the unborn child. Politically, RCRC lobbies for pro-abortion legislation and against pro-life legislation. Also, politically speaking, RCRC advances the notion of the "naked public square," by attempting to rule out-of-bounds the public expression of religiously grounded and motivated pro-life claims. Legally, RCRC submits briefs that encourage courts to decide for abortion rights. Again, consider the picture. In part because of RCRC's labors, the abortionproviding facility continues its work, day after day.

Because the Religious Coalition for Reproductive Rights does what it does, United Methodist institutions-namely, the General Board of Church and Society and the Women's Division of the General Board of Global Ministries-should be withdrawn from it. May God grant General Conference 2008 the moral clarity and strength to withdraw our agencies from RCRC.

Love screams, "STOP!" He listened. He did stop!

In the group discussions at the conference, Fr. PPL's call to the PC(USA) remains clear and we have answered: "We will stay and witness."


For more than 30 years Presbyterians Pro-Life has been a voice for life at every General Assembly, calling the PC(USA) to cherish human

In America we are often so busy fighting the plague of abortion within our borders that we forget that abortion and its aftereffects are a global plague. Internationally, World Relief and Human Care has been able to do some amazing things by creating hands-on, pro-active opportunities for women and families to choose life for their children. Now there are new opportunities to extend the Word of God into the life issues in other parts of the world. But more on that later; first let's see why this need is so great.

According to the World Health Organization (WHO), Asia accounts for 59 percent of the world's abortions. North America, by comparison, accounts for only 3 percent. It is estimated that at least 25 million unborn babies are unceremoniously killed in clinics and shacks across Asia every year. That is a rate of almost 50 preborn Asian babies killed per minute.

The reasons for this daily campaign of killing in Asia are as varied as the contexts found in the various countries. In Vietnam, for example, where abortion is freely available and sometimes even encouraged by the government in a macabre effort at population control, the abortion rate is the highest in the world. Nationwide, roughly one abortion is performed for every live birth in the country. Taking about 90 minutes to perform and costing only about US\$4.35 in a government clinic, abortion has become an easy and attractive option to end unwanted pregnancies.

Other Asian countries where abortion is available "on request" include China, North Korea, Mongolia, Cambodia, and Singapore. As the world's most populous country and having a liberal abortion policy, China has the most abortions in absolute terms-an estimated nine million per year. Official government population control policies in China contribute heavily to the abortion trend there. Chinese mothers often abort female babies-a practice known as female feticide-in an effort to produce a boy baby in a subsequent pregnancy. As in Vietnam, abortion is often encouraged, and sometimes mandated, by Chinese government authorities in order to end "unauthorized" or "improper" pregnancies.

In India, the world's second most populous country, abortion laws are only slightly less liberal, resulting in an estimated seven million abortions per year. Female feticide in favor of boys for cultural reasons is believed to be one of the leading causes of abortion. Although no longer legal in India, the payment of dowries to marry off daughters is still common practice. As a result, female children potentially pose a serious financial burden to poor parents. Boys, on the other hand, are more likely to bring in resources and, of course, dowries of their own when they marry.

In many other Asian countries, abortion laws are far more restrictive. Illegal-and generally unsafe-abortions still take place at alarming rates. In Indonesia, for example, abortion is only legal in cases of extreme medical necessity. Indonesian government authorities, however, estimate that around 30 percent of teenage Indonesian girls have had an illegal abortion.

While it is common to draw links between abortion and poverty in developing countries, the Asian context just described is more complex. Children are generally seen as an asset and not a financial burden to poor families in Asia, who normally welcome children and raise them in the expectation

## **LCMS Tackles Complex Problem of Abortion in Asia**

that they will work and support the family. India is an exception to this rule when it comes to girls because of the dowry system described previously. In most other Asian countries, children provide social security to the family while the government does not. It is misleading, therefore, to simply blame poverty for the abortion problem in Asia.

Unfortunately, in most Asian countries abortion is readily available, whether legally or illegally. As a result, it has become a seemingly easy and routine way out of a difficult or unwanted situation for many Asians. The reality, however, is that abortion is neither easy nor routine; it kills babies and leaves long-term emotional scars in most of the women who experience it. Abortion leads to a cheapening of the value of life in the eyes of the men and women who see it as a solution to an unwanted pregnancy, and can often leave Asian girls and women confused and scared, with deep psychological trauma and guilt.

In addition to this grim scenario, crisis pregnancy centers are rare in countries in Asia, and Christian centers are almost unheard of. Asian girls and women often feel they have no options and no place to go for help. But, there is hope: Christian Salvation Service in Taiwan, started nearly 25 years ago with assistance from LCMS World Relief and Human Care, has helped thousands of women from a Christian perspective, and arranged well over 1,000 adoptions for beautiful children who might otherwise have been killed.

In the three minutes it takes most people to read this article, another 150 Asian babies will be killed. The need for Christ-centered crisis pregnancy outreach in Asia is huge. Asian women and girls desperately need Gospel-oriented ministry. Buoyed by the success of the pregnancy resource centers in Russia, LCMS World Relief and Human Care is embarking upon an ambitious plan to replicate the Russian model by developing similar centers in Asia.

We are now in the process of designing project goals and strategies for collaboration with our partner churches in Asia. Once our funding for the first center becomes secure, we will begin the process of choosing a targeted location from among our partner grant applications.... As part of the living body of Christ, we are called to stand alongside women and children in these lands who live so far away geographically, yet so close in spirit. Your prayers will help support this exciting ministry
