### A Journey To Washington, DC

Early in March, just before the final votes on health care reform legislation in Washington, DC, I wrote a letter to the US House of Representatives on health care legislation which was allowing federal dollars to pay for abortions. As the letter was being duplicated, we considered the high cost of mailing the letter to 435 congressional offices and the slow delivery of first-class mail to Capitol Hill. So we decided on an alternative: hand-delivery.

After participating in our Wednesday evening Service of Holy Communion, my wife Marsha and I drove from Morehead City, NC north to the Motel 6 on the other side of Fredericksburg, VA. A short night of sleep and a dash to the train depot led to semicomfortable seats on a commuter train into Washington, DC.

By 9:30 a.m., we were distributing a copy of the letter to each congressional office on the top floor of the Cannon House Office Building (HOB). Marsha took one side of each hall, and I took the other. That way, we covered all the halls on a floor, and then we moved down a floor and repeated the strategy. After completing our task in the Cannon HOB, we delivered letters throughout the Longworth HOB -- one hall at a time, one floor at a time, moving downward. Leaving Longworth, we entered the gigantic Rayburn HOB and handed out letters in the same way until 4:30 p.m.



Those who greeted us in the congressional offices graciously and thankfully received the letter, engaged in friendly conversation, promised to direct the letter to the representative or other pertinent staffer in the office, and bid good-bye. It was all quite civil, even courteous.

The lunch break in the Longworth HOB cafeteria was memorably refreshing and renewing. Even so, by the end of the day, both of us were exhausted. The train returned us to Fredericksburg. We walked to the car, which had been parked at the

Fredericksburg United Methodist Church. Dinner was followed by the five-hour drive to coastal North Carolina.


It was a long day. It was a day we will never forget. As it turned out, our effort was not especially successful. But from the start, we were under no illusion that our effort would change the world (or the fate or shape of health care reform). Even so, this is what citizenship in the United States is all about -participating in the political process, seeking the common good, striving to protect the least of these among us.

Here is an excerpt from the text of our hand-delivered letter:

"In the Social Principles, The United Methodist Church officially recognizes not only the sanctity of unborn human life, but also the unborn child (Paragraph 161J, The Book of Discipline [2008]). So The United Methodist Church claims that the unborn are children and suggests that they are part of the human community. With these moral truths, the Church through

the ages and most Americans of our day agree.

Because unborn children are members of the larger society, federal legislation should stop federal dollars from paying for procedures -- i.e., abortions -- that would destroy such children. Since the 1970s, the Hyde Amendment has prevented the federal government from paying for many abortions. By standing between federal dollars and abortion providers, the Hyde Amendment has saved millions of lives.



Courage is always required to stand up and do what is right. It took courage for American preachers and politicians to oppose slavery in the 19th century. It took courage for German pastors and priests and people to oppose the murderous anti-Semitism of the 1930s and 1940s. It took courage for American clergy and laity and politicians to join the Civil Rights Movement and oppose racism. Now, courage is required of you to stand up and vote against health care reform legislation that would result in destroying, not caring for, unborn children."



### NPRC Board Members Attend NRLC Convention

The National Pro-Life Religious Council recently attended National Right to Life's annual convention in Pittsburgh. This year's convention featured several high-profile, pro-life leaders including, Steven Mosher, president of the Population Research Institute and Dr. Angela Franks, author of *Margaret Sanger's Eugenic Legacy*. Mark and LaRee Pickup gave a heartfelt talk at the Prayer Breakfast and Monsignor Jim Lisante was the keynote speaker at the Closing Banquet.

NPRC's board members have been presenters at numerous workshops over the years, and this year was no different. Rev. Ben Sheldon, of Presbyterians Pro-Life and Rev. John Brown of United Friends for Life discussed "Overcoming Pro-Abortion Opposition within a Congregation or Denomination." This workshop provides answers on how to work towards positive when confronted with a church leader or fellow church members who are hindering pro-life activities. Fr. Frank Pavone, of Priests for Life and Rev. Kirk van der Swaagh, of the Conservative Congregational Christian Conference lead a workshop entitled "Increasing Local Pro-Life Effectiveness in Pro-Life Religious Denominations." For churches that are already pro-life, this talk teaches how they can become great assets in the fight for life. And for individual members of active pro-life churches, attendees gained new information and ideas at the workshop.

However, NPRC's premiere event at National Right to Life's convention has always been the "We Are the Sheep... Where Are the Shepherds?" workshop. This talk features many of the NPRC board members in a forum setting where they discuss a common problem that many churches in the pro-life movement face: the fact that many pastors simply refuse to face the issue of abortion. Whether a congregation is predominately pro-abortion or predominately pro-life, many church leaders shy away from addressing life issues in their churches, often at a detriment to their members.

This year's talks were particularly inspiring and have proved to be valuable sources of information and advice. Meanwhile, the People of God should press forward in expressing their concerns, calling for corrective legislative action, and preparing for the elections in November," Fr. Pavone stated.

### **An Ecumenical Confession For Life**

Teaching Truthfully and Ministering Mercifully

# Statement by the National Pro-Life Religious Council May 1, 2010

### **Our Situation**

In our time and place, the dignity of the human person is under attack. Year after year, horrendously high numbers of abortions are performed in American society. Also, the proliferation of embryonic stem cell research, eugenics, euthanasia, and other similar problems exhibit a casual disregard for human dignity.

Occasionally, in the political arena and within church life, the great debate regarding human dignity surfaces. But most often, literally fearing disagreement, churches simply remain silent about these matters. Through their silence, churches in America prove themselves accommodated to American society and deepen their accommodation. Thus routine attacks on the dignity of the human person, in our country, can continue with few serious challenges.

In our time and place, it is crucial that churches (Protestant, Orthodox, and Roman Catholic) rely on God's Word and grace, demonstrate the unity that Jesus Christ gives, set aside fearful silence, and strive to teach truthfully and minister mercifully, "in season and out of season" (II Timothy 4:2, RSV here and following), with regard to abortion and other life issues. To assist churches in those tasks, the following ecumenical confession is offered.

### **Our Confession**

- I. We believe in the one, true, living, loving, Triune God, who is Father, Son, and Holy Spirit. This God reveals Himself in history -- through faithful encounter with Israel, most fully through His Son Jesus Christ, and through the Church (one, holy, catholic, and apostolic) in Word and Sacrament. This God speaks and acts. This God is not the creation of humanity's pious imaginations or spiritual enthusiasms.
- II. We believe that God the Father is the Creator of humanity -- that is, of each and every human person. "So God created man in his own image, in the image of God he created him; male and female he created them." (Genesis 1:27) People are not just products of biological processes.
- III. We believe that God the Son, Jesus Christ, is the Redeemer of the world. "In Christ God was reconciling

the world to himself..." (II Corinthians 5:19) Because of the Redeemer Jesus Christ's death and resurrection, no person in this world is without reason to hope. Even those who have participated in abortion or other degradations of humanity, in any way, are lavished with divine forgiveness upon repentance.

- IV. We believe that God the Spirit gathers the Church to teach God's truth and to minister God's mercy. "Speaking the truth in love..." (Ephesians 4:15) "Truly, I say to you, as you did it to one of the least of these my brethren, you did it to me." (Matthew 25:40) The Church has no authority to develop teachings or initiate ministries that contradict God's Word and will.
- V. We believe that God commands the Church universal, for the sake of justice, to protect and defend the unborn child and mother from abortion -- and other weak, defenseless, and voiceless people from violence. This divine command has been heard and understood since the earliest days of the apostolic Church. "You shall not kill." (Exodus 20:13) In a society that now hosts 1,200,000 abortions a year, in a society that convinces many of its citizens that a US Supreme Court decision that permits abortion also makes it right, in a society that seduces some churches to forget and/or resist God's Word about life, the Church's message and ministry on life will often be rejected.
- VI. We believe that God calls the Church to be public about her position on life and abortion. "You are the salt of the earth... You are the light of the world." (Matthew 5:13-14) When the Church is silent or inactive on abortion, she rebels against the Lord of Life and His Gospel. Because Jesus Christ is Life, and came that we might have life, His Gospel can be called a "Gospel of Life."
- VII. We believe that God, at The End of History, "will wipe away every tear from their eyes, and death shall be no more, neither shall there be mourning nor crying nor pain any more, for the former things have passed away." (Revelation 21:4) Until the glorious End, the Church will neither grow weary nor pause for rest in proclaiming and celebrating the Gospel of Life, and serving the Lord of Life.

She discusses ways churches can adapt and support women who seek to balance the priorities of ministry and family. A ministry of hope for those facing infertility is spotlighted.

"Pregnant with Hope," by Bethany Furkin, introduces Susan Radulovacki, a member of Peachtree Presbyterian Church, whose own experience with the pain of infertility prompted her to write a Bible Study to bring hope to those struggling with infertility. The article notes the importance of ministry that brings hope and support to couples facing infertility. The Peachtree Church conducts a Bible Study for infertile couples twice a year. Current projects benefit mothers and babies.


I found more good news on the denomination's website among the current ministry projects. PPL is cautious about

endorsing ministry projects of the PC(USA) because of the denomination's support for abortion. So, I am delighted that I am able to encourage pro-life churches to support two current projects that benefit women and babies. The need is great. We who uphold the value of human life from fertilization to natural death ought to be the first to give generous support to projects providing practical ministry to pregnant women and infants.

Our denomination continues to exhibit moral confusion about issues like abortion and care at the end of life.

Presbyterians Pro-Life is working diligently toward making changes at the General Assembly level that would move our church toward a more faithful stance--one that reflects the clear teaching of Scripture about the value of human life. Our next issue will focus on some of the business coming to the General Assembly that has implications for our witness to the world on life issues. Our GA team will be there in Minneapolis and we need your help to put on our events there and have a lively pro-life witness at the Assembly.
